RULES OF ADMISSION

- All the Admissions shall be made in accordance with the provisions of the relevant G.O.s viz., G.O.Ms.No. 64, Dt: 26.05.2006, G.O. Ms. No. 250, Dt.: 27.10.2008, G.O.Ms. No.31, Dt.: 18.03.2009, G.O.Ms. No.116, Dt::07.08.2007 as the case may be and their subsequent amendments.
- 2. All admissions are subject to Rules & Regulations of B.C.I. New Delhi, A.P.S.C.H.E., Hyderabad, Andhra University, Visakhapatnam and Convener, LAWCET from time to time.
- 3. Essential Eligibility Conditions (for 3 Yr./5 Yr LL.B. Course)
 - a) Candidate must be an Indian National.
 - b) Educational Qualifications:
 - Any degree from a recognized University in India in 10+2+3 for 3 Yr LL.B./B.L. Degree and 10+2 pattern for 5 year LL.B./B.L. Degree.
 - ii. Candidate should secure the following percentage of marks in the Qualifying Examination.
 45% of marks in aggregate for OC/BC
 40% of marks in aggregate for SC/ST
 (Minimum percentage of marks may vary as stipulated by the Bar Council of India, New Delhi and concerned authorities from time to time)
 - iii. Candidates who have secured less than the prescribed percentage but have secured the same percentage or more in aggregate in any P.G. Degree or B.Ed. are also eligible for admission into 3 year LL.B course.
 - iv. Candidates who have obtained (10+2) or degree by single sitting either through regular or private or correspondence more are not eligible.
 - v. Candidates, who obtained (10+2) or Degree through Open University system without having any basic qualification are not eligible.
- 4. All admissions under Management quota will be based on merit only.
